**Sergeant-at-Arms Report:** Acting Sgt-at-Arms, reported 28 members and one guest, Rosemarie Pitz.

**Minutes of Previous Meeting:**

The minutes of the Post Meeting on 5/26/10 were distributed and approved as printed. The PEC minutes of 6/16/2010 are also available.

**Election Of Officers:**

- Nominations were requested for each elected office, hearing no additional nominations the nominations were closed.
- A motion was made by Laurie Koepke and seconded by Jim Yost to elect all officers nominated by acclamation except the position of Sgt.-at-Arms, which will require an secret election. The motion carried unanimously.
- Ballots were distributed and a election was conducted for Sgt.-at-Arms. The result of the election was Jim Hoeft 6, Dave Schmude 9, and Jack Haynes 13. Jack Haynes will be the new Sgt.-at-Arms.

**Constitution and Post By-Laws:**

- First notice of the revised Constitution and Post By-Laws was made by Commander Deiss tonight. Copies are available for review on the website and several paper copies are available from the Adjutant tonight.
- There will be a second notice in the July newsletter and the revised Constitution and Post By-Laws will be voted on for ratification at the July Post meeting.
- Commander Deiss discussed several of the major changes in the revised Constitution and Post By-Laws, such as, Adjutant and Finance Officer will become appointed positions instead of elected and the Post have 2 Sgt.-at-Arms instead of one. Another change defines the Post will only paid expenses for the delegates and one alternate to state convention.

A motion was made by John Vonderloh and seconded by Ed Goss to donate \$500.00 to the Theron Coats family under the provision that a picture and article be submitted to the Omro Herald. The motion carried unanimously.

**Fundraising:**
